

❖ Acting President Rosa G. Diaz: (6:17 pm − 6: 18 pm)

She thanked everyone for attending the meeting. She started with being grateful for life. She said Thanksgiving is in two weeks and continue to work for our children.

 She spoke about District 4 data summary- Citywide enrollment in past 4 years.

Questions: (6:37 pm – 7:05 pm)

- Asalmah George: She asked, the students who are leaving 3 K and going to other districts for those students that were enrolled in District 4, 3 K's, the schools that they were going to?
- <u>Dr. Kristy De La Cruz:</u> She answered that the nuances of 3 k and pre-k but then the other thing that in the district and other district schools. We have pre-k programs that are in community-based partnerships. They are not actually in DOE buildings but they are operated by the DOE. So right now, we have a partnership with the early childhood, we have instructional coordinators and social workers that support all the sites, because they are DOE supported, even though they are not in a DOE building. We have had 11.4% increase in enrollment, and that doesn't even include our 3 K students. It only includes our Pre- K. So, we have increased 850 students. Parents do have choices..

- <u>D4 CEC Treasurer- Johanna Dominguez:</u> She asked, early childhood registration, is there any way to control the double enrollment because we know daycares affecting all the double enrollment.
- <u>Caitlin Whittemore:</u> She said that the numbers on the page we are looking at are only for students who are enrolled in a district for district early childhood site or a community-based organization site. So, when it says, District 4 schools at the top, that means, District 4, pre, K, 3 K or NYCEEC or a community-based organization.
- <u>PEP- Dr. Kalaris:</u> She asked that she wanted to be clear about the topic of video conversation yesterday, where Chancellor talked about the Law school and the merging of the schools.
- Dr. Kristy De La Cruz: She replied that right now, as a district, there are no mergers.

3. Office of Energy & Sustainability – Communications Coordinator – Elizabeth Schad: (7:05 pm – 7:18 pm)

She was excited to share about a brand-new initiative that they are launching in every single New York City public school this year called Climate Action Days. The Chancellor announced these earlier this fall. There are 4 days for every single school to do something for climate action. She said their goal is just to embed sustainability in all aspects of the school system, they work across a lot of different areas, both in the buildings and with students and educators and staff and engaging them in programming and education. Today, they all did plastic free lunch day. That means that their school cafeteria staff prepared and served that meal without any plastic.

She discussed, about office of energy and sustainability, waste reduction and recycling, energy management and clean energy, climate and sustainability education, indoor and outdoor green space, food and wellness, green teams and community, resources for schools, resources for students and families, flyers, and books. Every school has a designated sustainability coordinator. It is part of the Chancellor's regulation A-850. Climate action days, on these four days, every school in the NYC will engage in climate action to build a better future, for our students and our planet. 6.CEC4 Council Members School Visitation Report -

■ **D4 CEC Treasurer- Johanna Dominguez:** (8:11 pm – 8:14 pm)

She thanked the parent coordinator Ms. Diana King and said it was a pleasure to visit PS 375 school. They treated her with great respect, and she feels that it is great to support principals and staff and they understand that we are working together. Her concerns are that in the same school building they share with a district D75 school and in the same building they have private school on one floor and then on the other floors the school struggles with the playgrounds and open space.

She visited CPE 2 and met Principal Naomi and the other staff. Their main concern is technology, laptops for the students.

She informed that they are following up with all the schools, they have partnership with NAACP who is also giving the devices as well and they have partnerships with Verizon, they have the NAACP Verizon connect. They have a team, Renato De Silva, Lennys Patino, David Lethesba and Lori Ferguson, and any of our school leaders who say that they are struggling with devices. She said in covid many families got laptops from the schools and some do not work anymore, and kids need laptops to work.

They get replaced. The school will get a new one. Exclusive iPad is no longer available device. When a child is assigned a device, when they move on a lot of times the price goes on with them. School purchase device is going with the child. The school loses out on those devices and then that is where the devices get shorter and shorter, and it becomes very difficult. A lot of schools are now facing challenges where they do apply for resale. There is no more LTE service. Now all devices can be only connected to Wi-Fi.
